 - Proof of date of birth
 - Certificates to prove achievements in CCA, sports and games
 - Experience certificate
 - Proof of category, (SC/ST/OBC/Physically Handicapped/EWS) if applicable
 - NCC certificate
- The candidates will write self appraisal of approx. 100-150 words on the same day and will submit for scrutiny. This will include their strength, weakness, achievements, reasons for opting teaching as profession and reasons for joining Rashtriya Military School

- Interview
- Teaching Practice for short listed candidates
