Screening of applications will be done on the basis of the percentage of marks obtained in the concerned subject or qualifications higher than the minimum prescribed educational pre-requisites (in concerned subject only) as given in the advertisement or in actual experience. Afterwards that candidate will be called for Interview/Teaching Practice. It is intimated again that candidature of the individual failing to provide marksheets of each semester/ year will be rejected.

6. **Selection procedure will be a two days procedure:-**

 - (i) Scrutiny of original documents by the school. Candidates are required to produce the following documents in original for scrutiny:-

(ac) Certificates to prove achievements in CCA, sports and games.

(ad) Experience Certificate.

(ae) Proof of category (EWS).

(af) NCC Certificate (if applicable).

(ii) The candidates will be made to write self appraisal on the first day and submit for scrutiny and based on their performance in the self appraisal phase, the candidate will be called for the next phase of the interview process (i.e. Day-2).

(i) Personal Interview.

(ii) Teaching Practice

Note : Candidates scoring 50% and above in both self-appraisal and interview will only be subjected for the Teaching Practice.

7. Important Instructions to the Candidates/Applicants:

(i) Dates of Interview/Teaching Practice will be intimated to the eligible candidates only.

(ii) Candidates appearing for Interview/Teaching Practice will travel and stay on their own expenses.

(iii) Persons working in Central/State Govt/PSU must apply through proper channel along with the certificate from their establishment that no disciplinary action is contemplated/pending against them and that they have no objection in releasing them in case of selection.

(iv) The Commandant/Principal **shall not be responsible for any postal delay or failure.**

(v) The Commandant/Principal reserves the right to change the number of vacancies if necessary.
